- .036 Updates on Belle Fourche Industrial & Rail Park Ryan Kavan, City Engineer Ryan Kavan outlined the transload facility with two (2) main line switches, one (1) warehouse facility, crane, and salt/fertilizer building proposed for the Belle Fourche Industrial & Rail Park. Map, engineered drawing of facility and outline of funding referenced (attached for reference).
