


Bears attributes the increase in numbers to several

Belle Fourche Facility A Part of World Oil Production

Working Half a World Away | Belle Fourche Beacon April 29, 2020

Managing a project half, a world away is a challenge under the best of circumstances, but to Dr. Ahmed Rasheed, Managing Director of IDIC Specialty Drilling Chemicals, LLC of Alexandria, Egypt, making adjustments on account of Covid-19 is today's reality.

Dr. Rasheed flew into the US from Egypt on March 16. It was the last flight to embark to the US. He was using the same airlines and connections to get to South Dakota as he has for the past five years, but the usually completely full flight to Chicago was only at about 80%.

Dr. Rasheed speculated because it was known, the flight was going to be the last for the foreseeable future, it probably contained many passengers like himself that needed to be in America and didn't want to miss what might be their only opportunity.

He said on April 23, the last of three flights this month, to Egypt, left Dulles in Washington, DC. Under normal circumstances, after a time in Belle Fourche on the project, he may have returned to operations in Alexandria, however, at present there is no guarantee when any return flight to the US may be available to bring him back.

The Alexandria production facility, with social distancing measures in place much like the US, has been working at close to normal capacity. With the downturn in oil production this next week they will move to an "every other week" operations schedule.

Dr. Rasheed said that, "In Egypt many of the same types of closures as in America are taking place. One significant difference in Egypt is that after dark there is a military enforced curfew, and no one is allowed to leave their homes."

After arriving in March, he spent three weeks in self quarantine to make sure he was not carrying the virus and then proceeded full speed ahead on the project- a pace that is continuing on until the project is completed.

EZ Fabrication and Welding, the project's General Contractor has erected the red iron of the addition and is fast apace fabricating and installing decking and equipment on the four-story structure. When completed it will be enclosed and look like the original building.

We asked Dr. Rasheed if the world's over supply of oil would affect his project.

"No. At this point we will proceed as normal and work to complete on schedule." He went on to say, "Things have been going very well and we are meeting our construction schedule projections."

"We do watch what is happening industry wide very closely, remarked Dr. Rasheed.

The filling of reserves and extremely low oil pricing is required at best, if possible, to keep the oil wells going. "Oil industry officials know that it is very, very expensive, if even feasible, to re-start an oil well once it has been shut off."

"The two or three miles of very narrow pipe that brings up the oil from deep underground, when the pumps shut off, begin to fill back up with sand and ground materials, basically plugging it up way below the surface."

Dr. Rasheed is predicting that, "after the world economy restarts and oil production resumes there will be many wells that never operate again."

"The very high cost is part of it and also lowering the volume of overall oil production will build a more stable, sustainable market both in production and pricing."

In the long term, a stable oil market means success and sustainability for the products that will be produced in Belle

"When world oil production is back on, *Workover rigs will be putting wells back into production and IDIC products will be much needed in the process."

* Wikipedia: The term workover rig is used to refer to any kind of oil well intervention involving invasive techniques, such as wireline, coiled tubing or snubbing. More specifically though, it will refer to the expensive process of pulling and replacing a completed well.

GOVERNOR NOEM'S SMALL BUSINESS RELIEF FUND is now available. Just go to this website – sdgoed.com. A full guideline of loan parameters and eligibility requirements can be found here. Loans will be issued based on approval on a first come, first serve basis.

GOVERNOR NOEM'S SMALL BUSINESS RELIEF FUND

Appropriate Eligibility Requirements:

- 1. Be a small for-profit or non-profit business as defined by SBA, but with less than 250 employees
- 2. Physical presence in South Dakota
- 3. Established prior to March 2020
- 4. Provide a written acknowledgement from a South Dakota bank and/or certified public accountant that the applicant has made statements or otherwise provided information or evidence that supports applicant's claim that applicant's business has suffered a material negative impact from the COVID-19 pandemic.
- 5. Have a personal credit with a minimum score of 650; lower requires a special exception
- 6. Demonstrate 1:1 debt coverage ratio with the new debt factored under normal circumstances

Loan Details:

- 1. Amount:
 - Min: \$5,000Max: \$75,000
 - Maximum of 3 months operating expenses
- 2. Terms:
 - Interest rate: 0%
 - o Fees: none
- 3. Amortization:
 - o No payments for initial 6 months
 - o Maximum term of 60 months (prefer shorter term for smaller loans)
 - Automatic Payment Required
 - No pre-payment penalty
- 4. Security:
 - o Personal guaranties for any owner with at least a 20% share of the business
 - A blanket security agreement
 - o Loan over \$25,000 may require additional collateral (mortgage, etc.)
 - Loans will be made directly to small businesses

Loan Agreement Terms:

- Proceeds from the loan must be held in a separate bank account at a bank in South Dakota.
- Applicant must provide regular expenditure reports to GOED documenting that the use of proceeds were used for normal recurring operating expenses.
- Any funds remaining in the account after 3-month period will be paid back to GOED.
- Proceeds may not be used for any distributions or dividends to owners.
- GOED makes no assurances as to how approval or denial of this application will impact the applicant's ability to pursue other financing from the SBA or any other source.
- As a sub fund of REDI, these loans will be subject to annual audit by Department of Legislative Audit
- Board of Economic Development will review Eligibility Requirements and Loan Terms; a public monthly report will be provided to them on loan activity.
- Loans will be approved by the Commissioner of the Governor's Office of Economic Development*
- All application materials are confidential. Name of all loan recipients will be a public record.

GOED expects high demand for these loans, and applications will be evaluated on a "first come, first served" basis.
